AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR OAK

TREE (SUPPLEMENTAL DECLARATION FOR FNFF).

This Amendment to the Declaration of Covenants, Conditions and Restrictions for Oak Tree is made this 11th day of February, 2019 by Verde Land, LLC, an Oklahoma Limited Liability Company, (hereinafter referred to as "Declarant") and FNFF, LLC, an Oklahoma Limited Liability Company (hereinafter referred to as "Platting Owner");

WITNESSTH

WHEREAS, Signature Properties International, Limited Partnership, a Delaware Limited partnership, hereinafter "Signature", was the previous owner of property located at Oak Tree, an Addition in the City of Edmond, Oklahoma County, Oklahoma and as the owner of such property was the successor in interest to Unique Golf Concepts, Inc. and Landmark Land Company of Oklahoma, Inc. as the Declarant under the Declaration of Covenants, Conditions and Restrictions for Oak Tree filed on November 29, 1977, in Book 4419, Page 742 and as corrected in Book 5540, Page 1255 of the public records of Oklahoma County, Oklahoma, hereinafter called "Oak Tree Declaration";

WHEREAS, Oak Tree Rartners, LCC transferred its rights as Declarant to Verde Land, LLC pursuant to a Real Estate Agreement dated September 24, 2013 and an Assignment of Declarant Rights filed on October 28, 2015 in Book 12965 Page 79 of the public records of Oklahoma County, Øklahoma.

WHEREAS, pursuant to Article VII, Section 1 of the Oak Tree Declaration, Verde Land, LLC, as the Declarant, as that term is used in the Oak Tree Declaration, has the unilateral right, privilege and option to subject to the provisions of the Oak Tree Declaration and the jurisdiction of the Oak Tree Home Owners Association, Inc., (the "Oak Tree Association"), all or any portion of the real property described in Exhibit "B" attached to the Oak Tree Declaration as corrected, if owned by Verde Land, LLC, and if not owned by Verde Land, LLC with the consent of owner thereof, as long as the total number of Lots located on "Exhibit "B" under the jurisdiction of the Oak Tree Association does not exceed One Thousand Seven Hundred (1,700);

WHEREAS, Signature's rights, privilege and option as Declarant to annex or subject such property exists under the Class "B" membership in the Oak Tree Association terminates or until December 31, 1995 (as amended) which last occurs;

WHEREAS, the Class "B" Membership of Signature has not terminated under the provisions of Article III Section 2(b)(i)(ii) of the Oak Tree Declaration;

WHEREAS, the addition of real property by this Amendment and Supplemental Declaration will neither cause the total number of lots on the property shown on Exhibit "B" to the Oak Tree Declaration as corrected and under the jurisdiction of the Oak Tree Association to exceed One Thousand Seven Hundred (1,700);

WHEREAS, FNFF, LLC is the owner of property known as Long Iron of Oak Tree and The Forest of Oak Tree, certain tracts of real property located in Oak Tree, an Addition to the City of Edmond, Oklahoma County, Oklahoma, as more particularly described on Exhibit "A", attached hereto, which real property is a part of the real property on Exhibit "B" of the Oak Tree Declaration as corrected, recorded at Book 5540, Pages 1256-1257 in the public records of Oklahoma County, Oklahoma.

WHEREAS, FNFF, LLC desires to have Verde Land, LLC exercise its unlateral right to annex and subject such real property, FNFF, as more particularly described on Exhibit "A", attached hereto, to the provisions of the Oak Tree Declaration, as corrected, and to the jurisdiction of the Oak Tree Association;

WHEREAS, Verde Land, LLC, with the consent of FNFF, LCC desires to annex and subject the real property, Long Iron of Oak Tree and The Førest of Oak Tree, in the Oak Tree Addition, Edmond, Oklahoma County, Oklahoma, as more particularly described in Exhibit "A", attached hereto, to the provisions of the Oak Tree Declaration, as corrected, and to the jurisdiction of the Oak Tree Association; and

NOW, THEREFORE, in accordance with Article VII of the Oak Tree Declaration, Verde Land, LLC does hereby and by this Amendment and Supplemental Declaration annex and subject all of the real property known as Long Iron of Oak Tree and The Forest of Oak Tree, a part of the Oak Tree Addition in Edmond, Oklahoma County, Oklahoma, as more particularly described, and shown on Exhibit "A", attached hereto, to the Oak Tree Declaration, as corrected, and to the jurisdiction of the Oak Tree Association.

AMENDMENTS TO THE OAK TREE DECLARATION APPLICABLE TO LONG IRON OF OAKTREE AND THE FOREST OF OAK TREE

To the extent Oak Tree Declaration is contrary, the following structural and use restrictions shall apply to Long Iron of Oak Tree and The Forest of Oak Tree.

Section 1. Storage and Parking of Vehicles. There shall be no outside storage upon any Lot or the Common Area of any automobile, commercial vehicle, truck, tractor, mobile home or trailer (either with or without wheels), camper, camper trailer, boat or other water craft, boat trailer or any other transportation device of any kind. No Owners or tenants shall repair or restore any vehicle of any kind upon any Lot or Common Area, except for emergency

repairs, and then only to the extent necessary to enable movement thereof to a proper repair facility.

Section 2. Minimum Architectural Standards.

- (a) Minimum Square Footage. No residence shall be constructed on any Lot in the real property known as Long Iron of Oak Tree that has a square footage of less than 2,500 square feet exclusive of garage area. No residence shall be constructed on any Lot in the real property known as The Forest of Oak Tree that has a square footage of less than 3,000 square feet exclusive of garage area.
- (b) Exterior Material.

 At least seventy percent (70%) of the exterior of all construction on a residence must be of brick or rock; the remaining thirty percent (30%) may be wood, stucco, or masonite; drivet may not be used.
- (c) <u>Setbacks.</u>

 There shall be a five (5) foot setback on the sides of all Lots in the real property known as Long Iron of Oak Tree. There shall be a ten (10) foot setback on the sides of all Lots in the real property known as The Forest of Oak Tree.

Section 3. <u>Improvements and Structures.</u>

- (a) Approval.

 No improvements of any nature whatsoever shall be constructed, altered, added to, or maintained upon any part of the real property known as Long Iron of Oak Tree or The Forest of Oak Tree without prior written approval of the Oak Tree Architectural Committee under the Oak Tree Declaration, as corrected.
- (b) <u>Pools.</u>

 Above ground pools are not allowed except movable children's pools with a capacity of one hundred fifty (150) gallons or less and must be located in the back yard. All pools and hot tubs shall be approved in advance by the Architectural Committee.
- (c) Fencing.

 Wood fencing material and metal and masonry fences shall be allowed on a platted Lot. All fencing must be reviewed and approved by the Architectural Committee.
- (d) Mailbox.

 Residences must have a mailbox

 constructed of metal with a wrought iron appearance. The design, style and
 location of all mailboxes must be approved in advance by the Architectural

 Committee.
